

# Wilberforce University Alumni Association Election Notice

In compliance with Article XI of the Wilberforce University Alumni Association as amended, the general membership is herewith notified of seven (7) Officer vacancies and five (5) vacancies for the Alumni Board of Directors.

## Nominating Procedures

1. Properly endorsed Petitions nominating individuals to run for the above vacancies must be received by **WUAA P.O. Box 370 Wilberforce, OH 45384-0370**, with a postmark date no later than January 4, 2012.
  - A. Each petition must bear a total of ten names of alumni endorsing the nominees. It must include the signatures and addresses of each supporting alumnus.
  - B. Each petition must bear the signature and address of the individual nominee consenting to run in the election, and to serve if elected.
  - C. Candidates for a position in the Association must be financial and active with the Association, and if residing in an area where a local chapter exists, they must likewise be financial and active.
2. Each nominee must submit to the **WUAA** a brief biographical sketch in narrative form of not more than 125 words, and a clear recent head-shot photograph. Both should accompany petition.
3. The Director of Alumni Affairs and/or other designated persons will submit these petitions for approval to the Nominating Committee January 21, 2012. If in their judgment, the number of petitions received is sufficient, the said Committee will nominate additional candidates.

## Election Procedures

1. Ballots bearing the names, pictures, and biographical sketches of all candidates will be prepared and mailed from the **WUAA** no later than February 6, 2012.
2. All ballots must be returned to: **WUAA P.O. Box 370 Wilberforce, OH 45384-0370** with a postmark date no later than March 2, 2012. Ballots not timely returned shall be considered void.
3. The Election Committee will meet by March 17, 2012 to count the ballots and certify the results.
